



TERMS OF REFERENCE UMSC CA.R.E FUND (RESEARCH GRANT)

Background

UMSC C.A.R.E Fund (Research Grant) aims to encourage and nurture **academics to conduct research** that helps to improve the overall health and well-being of patients and communities.

Funding

The maximum duration is one (1) year.

Eligibility

Eligible Applicants

- (1) An applicant is a permanent or contract staff of FOM. For contract staff who is a PI, he/she must not be the sole researcher of the project applied. Research project must include a permanent staff as co-researchers.
- (2) The staff has a grade of DU56 / DUF54 / DS54 and below.
- (3) The staff does not have an existing grant as PI.
- (4) The proposed budget must not exceed RM30,000.

The purchased laboratory equipment(s) must be registered under the department. Upon completion of the research project, purchased equipment(s) shall be returned to the Department for common use. The researchers are encouraged to share laboratory equipment(s) to avoid multiple purchase of the same equipment(s) within the same department. Purchasing of Desktop and Laptop are not allowed under this Grant.

Guidelines for Application Submission

UMSC CA.R.E Fund (Research Grant) application must be submitted to the **Research Management Centre (RMC), Level 3, Block I, Faculty of Medicine**. The applications includes:

- (1) UMSC CA.R.E Fund (Research Grant) Form
- (2) Research Proposal (*Research background should include Research Questions and Literature Review, Objective(s) of the Research, Methodology, Gantt chart and Expected Results/Benefit, Research output)* not more than 5000 words.

Incomplete documents will be rejected and will not be submitted for review. The applicant is responsible for ensuring the completeness of the application.

Upon completion of the review process, shortlisted proposals will be forwarded to the UMSC CA.R.E Fund Committee for final decision.

For successful recipient, the PI needs to:

- 1. Publish at least (1) publication in ISI/Scopus related journal
- 2. Acknowledge the grant's name
- 3. Submit the progress/final report (6th month and 12th month)
- 4. Present the outcome of the project to the committee upon completion of the project

Note: The duration of the project is based on the date of approval by committee members and not as mentioned in the application form or proposal. Request for project extension is not allowed.

Grant recipient will be notified of the decision via an official letter by the UMSC CA.R.E Fund secretariat.
